ESSO PETROLEUM CO LTD – FAWLEY TO AVONMOUTH PIPELINE – CIPS SURVEY

We are writing to advise you that our client, Esso Petroleum Co Ltd, will be carrying out a CIP survey (Close Interval Potential Survey associated with the management and monitoring of the pipeline) of the route of its Fawley to Avonmouth Pipeline in accordance with the terms contained within the Deeds of Grant. Such inspections are undertaken to ensure that high standards of safety are maintained. Esso Petroleum Co Ltd representatives will begin walking the route from 17th September 2018 onwards. The Survey entails laying of a very light copper wire on the surface of the ground. Typically there will be 2-3 people involved and the wire is connected at an existing test post and is retrieved once the next test post is reached so at the most it is on the ground for a few hours. Readings are gathered and the wire is not left overnight. In the case of livestock being present in a field, it would be most appreciated if they could please be moved when this survey takes place, we can give 48 hours notice to do so if this is necessary. Please contact the Hungerford office should this be required on 01488 662750.

Esso Petroleum Co Ltd identification will be displayed in vehicles and care will be taken to ensure that parking causes no obstruction. Where possible our representatives will keep to the pipeline route with appropriate use of adjacent stiles and gates. This Survey will take approximately 4 weeks.

If any of the above details are incorrect could you please let us know so that our records are kept up to date. If you are aware of any hazards on your land which may pose a significant risk to our personnel could you please let us know as soon as possible either by post or Freefone 0800 136812.
